Prior to Statehood of the Goa, the Goa State Co-Operative Bank (GStCB) was functioning as Apex Bank of Union Territory of Goa, Daman and Diu. On this backdrop, the RBI had directed to shed the Goa State Cooperative Bank's operation in Daman & Diu Region. Accordingly, the bank had adopted all the required procedure for bifurcation and the Daman Diu State Co-Operative Bank (DDStCB) came into being as a new entity with effect from 01.04.2017 with its Head Office at Nani Daman. The area of operation of the DDSCB covers the entire Union Territory of Dadra & Nagar Haveli and Daman and Diu. The bank has 5 branches in Daman region while 4 branches and 1 Regional Office are located in Diu Region.

The DDStCB has since taken up the exercise of updating the bank's shareholders records and decided to allot the Share Certificate of the Daman & Diu State Cooperative Bank Ltd., Nani Daman to all those share holders of the Goa State Cooperative Bank Ltd., residing in the Union Territory of Dadra Nagar Haveli and Daman & Diu.
